## Employment

Her employment practice often overlaps with her commercial work, including advising on post-termination restrictive covenants. She has also advised on employment law issues in Caribbean jurisdictions

## Public Law and Inquiries

Emily has a keen interest in public, administrative and constitutional law. She is currently instructed on the COVID-19 Inquiry, acting on behalf of the Department of Health and Social Care. She is also instructed on the Undercover Policing Inquiry, which aims to investigate and report on undercover police operations conducted by English and Welsh police forces since 1968, acting on behalf of the Designated Lawyers officer core participant group.

Emily's public law experience also extends to appeals before the Judicial Committee of the Privy Council. She assisted [Tom Poole KC](#) on [Sexius v Attorney General of Saint Lucia \[2017\] 1 WLR 3236](#), which has now become the leading case on the scope of the right to silence and its interplay with the right to a fair trial.

Emily has also represented detained clients pro bono through Bail for Immigration Detainees.

## Travel & Cross Border Claims

Emily is regularly instructed in cross-border claims involving issues of jurisdiction and conflict of laws. In travel law, Emily has substantial experience acting for a number of well-known tour-operators and airlines in a range of claims under the Package Travel Regulations, the Montreal Convention and the Denied Boarding Regulations. Emily has also acted as junior counsel in appeals before the Privy Council.
